

Silversmith House restoration moving ahead Thanks to Community Foundation, Duff McDuff Green Jr grant

It might not be visible yet, but Silversmith House repair priorities are getting attention, thanks to the \$10,000 grant from the Duff McDuff Green, Jr. Fund of the Community Foundation of the Rapahannock River Region.

The Fredericksburg Center for the Creative Arts, caretaker of the historic house, received competitive bids to replace clapboards at the back left corner of the building, and scraping and painting of the entire outside, minus the shutters.

According to Michael Randall, Board of Trustees chair of building and grounds, he will skinny down his list of potential contractors, and invite the final three in for more in-depth assessment and conversation. Repairs should begin soon after the FCCA chooses a contractor.

Other priorities on the repair list include windowsills, shutters and masonry work. "We are working to obtain funding to proceed after the corner repair and painting are

completed," said Randall.

The Community Foundation unifies charitable gifts of individuals to provide leadership and financial leverage to address needs of the community.

Take Note

The Silversmith House, circa 1785, is an example of a middle-class family's home just after the Revolutionary War. The property is also the site of Fredericksburg's first Fourth of July celebration in 1805 and was used as a forward Union hospital during both Civil War battles for Fredericksburg.

Irosh to **2Pt** Clean up & make masterpieces







March 2013 - Faces & Figures Juror's Statement Joseph Di Bella

One question is always at the top of viewers' minds (and often strongly voiced) when they take in an exhibit of selected works: Why did the juror choose that piece? And there are variations of this question: What was the juror thinking? Were the juror's choices based on subjectivity or objectivity? Is the juror qualified to judge this kind of theme when he doesn't even make art that addresses this theme or doesn't work in these particular mediums?

It may seem baffling to artists and viewers of art how the selection process functions and how the same work can be accepted in one exhibit and declined in another. I know. That's been my experience with some of my work. However, as an artist, a student of art, a teacher of artists and a juror for many years, I can express how the process unfolds for me. It's about objectivity and subjectivity, familiarity and surprise.

When I "read" a work I initially rely on first impression, how the piece strikes me. That instant reaction then quickly transitions into an analysis of three equally important and interdependent components: message, material and means. Message is concept, content or meaning. Material is the medium and the way it is handled, its technical qualities. Means is structure, the form or composition. In some works these components are so organically fused there seems to be no distinction among them. This assessment is objective: How each of these components qualifies the others. I rely on my familiarity with making, viewing and studying art to arrive at this. But there is also the subjective and this is when "surprise" kicks in. This happens when the logic of these demonstrable components yields to the artist's peculiar dialogue with the viewer. Sometimes the unexpected occurs even within an established genre or style: The artist's idiomatic presence. When all of these pieces seamlessly join, the art conveys its fluency and the viewer is engaged.

For this exhibit of Faces and Figures, I sought what would engage me and sustain my attention. Although our acquaintance with the human face and body is common, I sought those works that made me see uncommonly.

of flowers and plants and their beauty, rhythm, and colors. I use acrylic paint for its consistency and versatility. In the past I have used a lot of water with the paint for a very washy effect but currently I have found that using a little heavier paint and layering colors lets me achieve the look that I desire. I also do not start with a white canvas; I have discovered a brand of gesso that comes in a wonderful range of colors and that is my background. It gives the canvas a nice surface on which to draw and when I apply my paint I sometimes let the background color bleed through. It sets the tone for the whole painting.

I visit gardens and conservatories and take many photos to use as references for my paintings. I am able to zoom and crop the images using Photoshop to come up with the desired compositions. I look for shapes, both positive and negative, when deciding on what to paint. I am not always true to the colors represented in the photos and do a lot of decision making along the way as to background, flower and foliage colors.

I am inspired by the colors of Matisse and Gauguin, the linear flow of Van Gogh, and the brilliance of Cezanne.

There has never been a time that I have not thought of myself as an artist.

2014 Members' Gallery Call for EntriesGet busy! It's not too early to prepMembers' Gallery

2014 is a long way off, but it already time to consider your art for the 2014 Members' Gallery line-up. Twenty-two spots are available in 2014!

The 2012 and 2013 Members' Gallery has featured solo art exhibits and quality ones at that. There was an FCCA record of 43 entries for 2012 submissions, but the number of 2013 submissions dropped. To encourage more entries, 2014 will feature up to two artists each month, January-November.

As in years past, the selection process will continue to be fair, anonymous, and as confidential as possible. I've invited three, out-of-town jurors to convene in August and evaluate entries. The jurors will also help decide on artist pairings based on entries. In the unlikely event there are less than 22 submissions, artists of top rated portfolios will be offered a solo exhibit opportunity.

I hope you will consider entering. The Members' Gallery is a rather unique artist benefit. As before, all types of artwork is encouraged. Three dimensional artwork has been more prominent at FCCA lately and 3D submissions are certainly encouraged.

So snap high-quality photos of your mosaic work, textiles, pottery, drawings, sculpture, paintings, photography, lithography, screen-printing, digital graphics, mixed media, etc. Or hit the studio hard since you still have time!

Entries for 2014 must include a completed application from the FCCA website or docent desk, one original artwork, and four high quality jpeg images e-mailed to me at membersgallery@ FCCAva.org.

Or entries can be submitted on a CD with four high quality jpeg images. FCCA member, Carolyn Beever, has offered to professionally photograph applicant entries for artists who need digital images on CD. A date will be forthcoming for those interested.

Artists can make appointments with the FCCA docent for these photos when a date a been set. There are no thematic requirements, although entries should best represent your creative style and vision.

At the end of the juring, each artist

A signature member of the National Watercolor Society and affiliated with other professional art organizations, he has exhibited in regional, national and international venues. 
