Freeze: Silversmith House stays open without heat

Docents, local company come to the rescue

The Silversmith House was without heat for much of January, just as subzero temperatures hit Fredericksburg.

As an icicle hung from the faucet upstairs, resolute docents kept the building open for visitors. Docents used a few space heaters to keep water pipes and visitors warm.

Lee Cochrane, docent coordinator, said "I am proud that our intrepid docents kept the doors open during these trying times. Everyone showed up and did their jobs. They just had to wear a couple extra layers."

A wayward wren swooped into the building searching for shelter. Cochran said, "If that wren was in search of warmth, it made the wrong decision." All Seasons Heating and Air, LLC,

repaired the heating system. Owner Gerry Slack provided replacement parts at wholesale cost and donated his labor to make the emergency repairs.

According to Carrol Morgan, Frederick Gallery curator, Gerry and his technician spent nearly an entire day repairing the gas furnance and ensuring the heat would not fail as night temperatures continued to be subfreeaing.

"Please keep this company in mind when you need heating and air services," said Morgan. "FCCA is fortunate that Michael Taggart, FCCA board member and owner of Plumb Magic, referred our emergency to Gerry, whose wife is an FCCA member. Thank you Gerry, for your generous support during out emergency."

December 2013 / January 2014 - It's Small Juror's Statement *Rob McAdams*

I am always filled with humility, awe, pride, and gratitude, when asked to jury an exhibition. For this show I was mostly filled with wonder though, and that wonder grew and expanded as I looked at over 173 submitted entries. I wondered how the works selected from digital slides would translate in person.

I wondered about the dichotomy of small work and how the structural scale can, at times force the perspective from close-up to a big 10,000-foot view. Crossed Paths is a perfect example; am I looking at a farm from an airplane window or a slide in a microscope?

I marveled at each artist's decision making as most of us paint with pretty normal sized brushes; the marks, brushstrokes, and artist's hand all are right there on the surface, not hidden by a large format. Ana Rendich's "After the Snow" was a great example of each stroke adding meaning to the work, and her subtle use of under-painting and mixing of colors demanded first place in the show. I wondered how Joyce Leatherwood's "Meadow Walk" piece was made and how many leaves Karen Fitzgerald went through to find the few she used in "Still I Rise." And any questions I had about Katherine McAskill's "Into the Woods," which was a great small piece with a small boy walking into a massive forest, I got answered by the boy himself who was there at the opening.

Finally I wondered why I am so lucky to be asked to look at the work gathered by the incredible people at FCCA, and why they bring such great food to the openings and laugh at my jokes. I guess I will never know, and I will just appreciate the small experience of a few hours in a small Fredericksburg space that feels like it could be any gallery in the world.

year or so ago, you might say I fell down the rabbit hole. Previously, I had painted still-lifes of rabbits in a Matisse mode. Then I turned to painting large shore birds in a



similar style. Still restless, I recalled my photos of rabbits in the wild. Opting for a more playful approach, I reimagined them alive in their natural habitat and painted away.

My canvas showed a totally new approach. Gone were my usual bright colors. My palette

was replaced with subdued, experimental colors that captured the essence of the living rabbit. I started using thin and thick washes that began and ended inside and outside the rabbit. In this series I experimented with leaving some of the canvas white. I let the paint drip and run on the canvas, searching for the spirit of the animal. Taking from the photograph what I needed, I painted my interpretation of the animal with loose, bold paint strokes. The whole time I was painting, I was so involved in the process that I was unaware of how I was painting. I was just having fun.

When I looked at the finished work, I was very excited about what I had done and knew that I had found my new way of painting and my next series. I paint what I am passionate about; something inside me has to say, "I want to paint that!" I have always desired to color outside the lines. Falling down the rabbit hole has let me do just that.

Specs for gallery entries

All entries submitted to Frederick Gallery exhibitions must be original and completed within the last two years. The two year limitation encourages and promotes entering new work that is fresh to our viewing public. Original means the work is the creation of the artist and is not a copy or version of another person's photo or artwork. Artists using reference materials should use only their own photos and sketches.

The appropriation of images may be an infringement of copyright laws and illegal, as well as unacceptable in our gallery.

If an artist is using borrowed images (appropriation of another's work), the work must be substantially altered in order to be considered original and may require written consent. Works created in classes or workshops are acceptable if created free from instructor manipulation and are not a result of copying a class/instructor exemplar.

Calls for entries requests

Many FCCA members have requested to receive mailed copies of all Calls for Entries for regional and national Frederick Gallery juried exhibits. The cost of printing and mailing Calls for Entry prospectuses has increased, and the mailing list will be updated to remove the addresses of artists who have not submitted work to a juried show for more than twelve months.

All Calls for Entry submission forms are available on our website www.fccava. org under the Frederick Gallery tab. Please help us to save valuable resources and let me know if you no longer want to receive mailed prospectuses.
