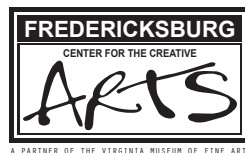

- Gallery provides pedestals for 3D work.
- No saw tooth hangers.

A non-refundable entry fee must accompany the submissions.
