FCCA agrees to exhibit the artwork of said exhibitor between the dates of **February 1 and 28, 2020**. FCCA will provide publicity in Fredericksburg, VA and surrounding area and agrees to host a public reception on First Friday, **February 7, 2020, at 6:00 p.m.** FCCA agrees to accept monies and VA sales tax in payment for artwork offered by said exhibitor for sale. FCCA will retain 25% of all sales. FCCA will forward sale monies to said exhibitor within one month of exhibition closing date.

The EXHIBITOR, \_\_\_\_\_, agrees to deliver **all artworks** accepted to be exhibited, including an **Artist Statement (optional Resume/Bio), Signed Contract, and Prepaid Shipping Label** (if return shipping required), to FCCA at 813 Sophia Street, Fredericksburg, VA 22401 on/or before the date of **January 31, 2020, by 4 pm.** (Gallery hours: **closed Tues.**, open Mon., Wed., Thur., Fri. 12 – 4, Sat. 11 – 4, Sun. 1 – 4). Exhibitor agrees to deliver artworks in suitable condition for public display, with each work labeled on back with **Artist’s Name, Title of Artwork and Exhibit Title**. Exhibitor agrees to pick up artworks, or arrange for return shipping, or pick up. Exhibitor agrees to remove all artwork by **Feb. 29, 2020\*** or within 10 days. FCCA does not insure artwork. Any artwork remaining thirty (30) days after this date without prior arrangement will become the property of FCCA. The exhibitor agrees to pay FCCA its 25% commission on all artwork exhibited at FCCA that is sold within 60 days of the close of the exhibition if the sale is a result of exposure gained from FCCA. FCCA reserves the right to reproduce accepted artwork for publicity purposes, including posting on our website.

**All artwork will remain on display for the duration of the exhibition through 4:00 p.m. (No exceptions UNLESS SOLD).**
