Deadline

All entries must be received by **March 13, 2020.** All work must remain on display for the duration of the exhibit..

Specifications

All work submitted must be original and completed within the past **two** years. **All media eligible.** No saw tooth hangers.

Liability & Agreement

- FCCA reserves the right to reject from exhibition works accepted by juror, due to content or inability to properly install the work.
- A 25% donation of sale price is required of all sales.
- By submitting work for entry, artist agrees to allow representations of work to be shown and reproduced for publicity purposes.
- Although every care will be taken by the FCCA, the exhibition committee and the Frederick Gallery, liability cannot be assumed for loss or damage of submitted works. It is suggested that artists wishing protection insure their works independently. Submission of a work to the exhibition shall constitute an agreement to comply with all conditions set in this prospectus.

Juror

Juror: Steve Griffin has been a painter for over fifty years. In 1968 he was one of twelve undergraduate students, selected from a national pool, to attend the first year of the newly created Independent Study Program at the Whitney Museum in New York City.

Since retiring from teaching in the Art Department at the University of Mary Washington in 2008, Griffin has continued to be an active exhibiting artist. He received a Professional Fellowship in painting from the Virginia Museum of Fine Arts in 2012 and a fellowship from the Virginia Commission for the Arts in 2013. Griffin has also been awarded three residency fellowships at the Virginia Center for the Creative Arts.

Griffin's work hangs in many private and corporate collections and is represented by several galleries including the Glave Kocen Gallery in Richmond and the Long View Gallery in Washington, DC.
