The Exhibitor agrees to remove all artwork between **10:00am - 11:00am on Friday, January 21, 2022**. FCCA does not insure work.

The Exhibitor agrees to the following conditions: (1) all framed 2-D artwork is ready to hang with suitable hanging wire; and (2) FCCA will retain 25% of all sales.

Exhibitors are strongly encouraged to sign up for one 4-hour timeslot as a FCCA docent during the show exhibition dates.

FCCA retains the right to decline any work due to content or inability to install properly.
